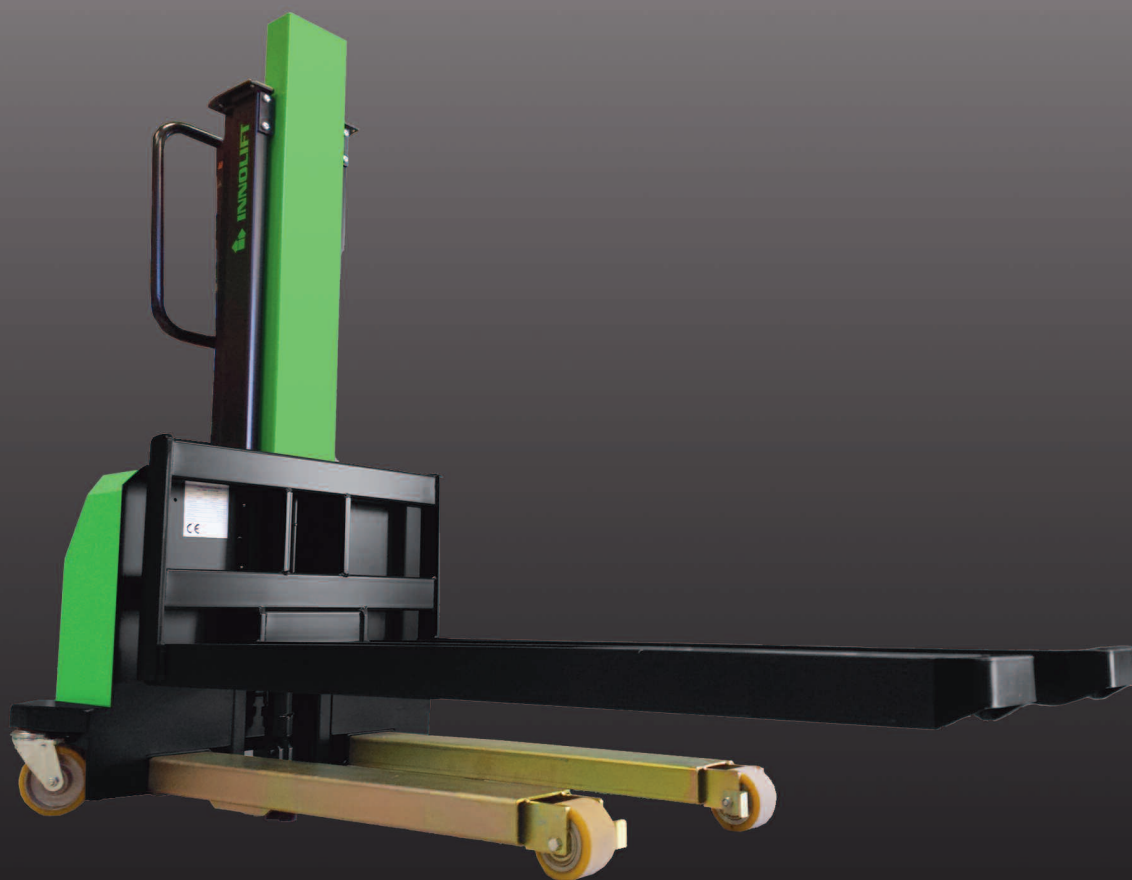

Service and Maintenance Contract



This contract for equipment maintenance services between

_____ (hereafter referred to as Client) and

InnoliftUK Ltd. (hereafter referred to as Contractor)

is made and entered into on _____

The Client owns or has legal control of certain equipment, specified and described in the List of Equipment attached and hereby incorporated into this contract by reference. The Contractor will ensure that the Equipment be maintained in good working order. Such maintenance services are to include annual inspections; routine, scheduled repairs and replacements of parts as needed; and emergency repairs made whenever any of the Equipment breaks down unexpectedly. In the event of a breakdown, the Contractor will endeavour to attend the site within 24 hours, to assess the machine. The Contractor will either repair the Equipment on-site, or replace the equipment temporarily, whilst repairs are carried out off-site, once assessment has been carried out by the Contractor.

Contractors Obligations

The Contractor is in the business of providing equipment maintenance services, and hereby undertakes to provide the following maintenance services to Client:

1. All of the Equipment listed shall be inspected and repaired on an annual basis.
2. The Contractor shall respond to any of Client's requests for emergency repairs within 24 hours of receiving such a request from Client via phone or email, or other communication method to which the parties may agree.
3. In the event of non-repair on site there will be a temporary replacement, Innolift machine provided, equivalent to your existing machine, free of charge.
4. The Contractor shall ensure that all services provided under the terms of this contract are performed by persons trained and certified as proficient in the provision of the services provided by an accredited school or manufacturer's training program.
5. The Contractor represents and warrants that all personnel provided by Contractor to do work on Client's equipment are legally eligible to work in the United Kingdom; and that Contractor complies with all applicable employment laws, and with all other applicable laws and regulations pertaining to the services provided to Client.

Clients Obligations

In consideration of services provided by Contractor, the Client agrees as follows:

To pay to Contractor the sum of £395 + VAT (at the current rate)

on the _____ of each year during the term of this contract,

This contract shall expire on _____

OR

To pay Contractor a monthly sum of £33 + VAT (at current rate)

on the _____ of each month during the term of this contract,

Commencing _____

at which time the parties may extend it by agreement in writing.

Either party may terminate this contract at any time by providing written notice of intent to terminate the contract on a specified date to the other party, at least two weeks prior to the intended date of termination.

Any dispute or cause of legal action that may arise from either party's performance under this Contract shall be governed by the laws of the United Kingdom. Any litigation arising from this Contract shall be filed and tried in the Contractor's local jurisdiction.

Both parties whose signatures appear below hereby warrant that they are fully authorized and entitled to enter into this agreement, and do so agree on the dates written below by affixing their signatures below.
